

CHESHAM CEMETERY – TABLE of FEES Commencing: 01 April 2019

The fees, payments and sums set out below apply:

- (i) where the person to be interred was, immediately before his death, or the person to whom the right is granted is an inhabitant or parishioner of the Town of Chesham.
- (ii) in the case of a stillborn child, or of a child whose age at the time of death did not exceed one year, where the parents (or one of them) are, or at the time of interment were such inhabitants or parishioners.
- (iii) where a Chesham resident has passed away in a nursing home or hospice outside the town, having moved in the previous twenty-four months.

In all other cases, the fees, payments and sums will be doubled

except those set out in Parts I and IV will not be doubled where the exclusive right of burial in the grave in question or the right of constructing a grave or vault was acquired at the single fees as set out in Parts II and III.

Interments accepted by the Council with less than three working days' notice or to take place on non-working days will incur additional charges.

CHILDREN'S FUNERAL FUND

Please note all parents are entitled to the services listed below on a free of charge basis via the Government Children's Funeral Fund (CFF) if the child is aged between 24 weeks gestation and 18 years.

- Cost of a burial plot (for a body or cremated remains and the cost of an exclusive right of burial in a plot appropriate to the size of child
- Fee for carrying out the burial, cremated remains or scattering of cremated remains.
- Maintenance costs of the grave up until the time the child would have reached 18 years old.
- Fee for permission to erect a memorial including a headstone/tablet but not the fee of the memorial itself.
- Fee for any renewal of the right of burial if it expired before the child would have reached 18 years old.
